## A Little Piece of History

This year, the town turns 250 years old. Joseph Chapline chose Sharpsburg as a place to settle, mainly because of the "Great Spring", located in the alley behind East Main Street. He called the town Sharps Burgh, in honor of his friend, Governor Horatio Sharpe. One hundred and eighty three lots, measuring 103' x 206' were laid out throughout the town, along with smaller lots in the "town square." The lots were sold for two pounds (or \$10.00.)

Sharpsburg and Hagerstown were both very interesting to new settlers, both competing to "win them over." The battle continued until 1776 when Hagerstown won the County Seat to Sharpsburg by one vote.

Today, Sharpsburg still looks much like it did in the 1800's when 1650 people called Sharpsburg "home." The residents take great pride in preserving its rich heritage and history. We are proud of this small town and are content with our way of living.

With the Birthday of the founding of Sharpsburg approaching (July 9<sup>th</sup>), the town and community members are working hard on commemorating this special event. We hope that you will be as enthusiastic as we are in celebrating this special piece of history.

### Council Minutes

The minutes of the Mayor and Council meeting are an abbreviated version of the official minutes. The official minutes are available at the office of the town clerk.

#### January 7, 2013

Prior to the meeting, Dennis Weaver, Clerk of the Circuit Court, swore in new councilpersons Brenda Gabriel and Russ Weaver. Hal Spielman was also sworn in as Mayor.

Members Present: Mayor Hal Spielman, Vice Mayor Bryan Gabriel; Councilpersons Brenda Gabriel, Darryl Benner, Russ Weaver, Cathy Hull and Brandon Smith. Kimberly Fulk, Town Clerk/Treasurer was also present.

The meeting was called to order at 7:08 pm by Mayor Hal Spielman. The minutes of the November meeting were read and approved unanimously. The November and December treasurer's reports were approved unanimously.

#### **PUBLIC COMMENT**

Dale Settle would like the minutes and reports available at the meetings. Darryl moved to place copies out for audience members and Russ seconded the motion.

JP Phillips of Apple Valley Waste presented an incentive program that Apple Valley is starting. This program includes a key tag that can be presented at local businesses to receive 10% off of certain goods and services. This would help promote local businesses and also is a "thank you" to customers of Apple Valley Waste. This service has been extended to include business and municipality accounts. Russ moved to approve the town participating in this program and Darryl seconded the motion. The motion carried. Kimberly will get a list of town residents over to JP at Apple Valley so that they can mail out the key tags.

#### **COMMITTEE REPORTS**

**Parks and Railroad Station:** The Railroad Station added a new gutter system to the building. This was done without the approval of the Maryland Historical Trust. The Trust reported that they understood why the upgrade was needed and in the future to remember to get approval for all additions and upgrades through them first.

**Building:** Kimberly reported that Simplex Grinnell was here in November to test our fire panel. The building passed, however; the inspector suggested reconfiguring some ducts. After discussion is was suggested by Darryl to wait on this and to put it into the budget for the next fiscal year.

**Streets:** High Street by the ball fields was discussed once again. We continue to have a problem with flooding. Darryl had his neighbor take a look at the area and he is suggesting forcing the water across the street and have it go into a drain. Kimberly will talk to Ralph Weaver of the county roads to see what his recommendations are.

Darryl also mentioned some pot holes in alleys that are becoming worse. Mayor Spielman will check into the possibility of having someone with extra black top from a job stop by to patch this up. The iron bridge at the alley that leads behind Bender's is in rough shape. It needs to have the iron rails redone and repaired. Brandon stated that he could get Clint's Welding to take a look and give an estimate to repair this.

Darryl mentioned the bridge from 34 to East Chapline Street is in rough shape as well and the guard rails are bent and deteriorating. Mayor Spielman stated that the State has told him that this is not their responsibility and it would be up to the town to repair. After much discussion, Mayor Spielman stated that he would contact the state again to see if they will not do something about this.

**Planning and Zoning:** The Comprehensive Plan is with the Planning and Zoning Committee and they will be presenting it to the Mayor and Council in February.

Battlefield Advisory Committee: Mr. Jamieson was not present at the meeting, but spoke with Kimberly beforehand. He stated that he would not be in attendance at the meeting, but he has informedSuperintendent Trail to email Kimberly if there were significant items discussed to be placed in the crier.Public Safety: Nothing to report.

**Mayor's Report:** Sharpsburg is hosting the MML Dinner for January. It will be January 28<sup>th</sup> at Shepherd's spring. The details were passed around for the members to sign up.

**Old Business:** The Town's 250<sup>th</sup> Commemoration was discussed. Vernell Doyle is leading a committee that is planning some activities for a town celebration on Sunday, July 7<sup>th</sup>. She stated that they would like to join forces with the town to sponsor these events, with the hope that the event could be covered under town insurance. Mayor Spielman stated that this would be discussed by the council and he would notify them of the decision. They are having a meeting January 15<sup>th</sup> to further plan events. Everyone is welcome to attend and be a part of this event. So far they have been working on a raffle, signage for the Great Spring, an ice cream social, a book signing and possibly a ceremony at the Chapline plot in Mountain View Cemetery.

There is a community meeting being held on Tuesday, January 8<sup>th</sup>. This meeting is open to everyone and it will focus on items that people feel are needed/wanted within the town so that grants can be applied for to possibly get these items.

Mr. Weaver mentioned election correspondence that was distributed to the town by candidates running for council. He wanted to make it clear as to why the townspeople at one time received a \$60.00 rebate for water and sewer and now that is no longer being distributed. The town at one time received monies from the State and the County for repairs, highway revenue, etc. Now, the state has cut these funds by about \$40,000. There is no longer the money available to refund the townspeople for the water and sewer, but this was done when the funds were available. Mayor Spielman also noted that he sent the candidate a two-page letter responding to that and many other questions the candidate had. Darryl stated that he wanted to thank the Christmas Committee for all of their time and efforts. Next year the town will need to make other arrangements for trees for the school if they plan to participate.

**New Business:** The Fishing Rodeo is usually the first Saturday in May. This year it would be May 4<sup>th</sup>. We need someone to Chair this event.

The meeting was motioned by Cathy to enter into a closed session to obtain legal advice at 8:10pm and seconded by Brandon. The members went to closed session. At 9:35pm, Russ moved to return the meeting to open session and Cathy seconded the motion. The motion carried. At 9:36pm, Cathy moved to adjourn the meeting and Russ seconded with all ayes for approval.
