

# **COUNCIL NEWS**

These minutes are not the official minutes, nor are they a complete review of the business conducted. Requests for a copy of the complete minutes may be requested from the town clerk.

The meeting of the Mayor and Council was called to order at 7:08pm by Mayor Spielman. Jennifer Silbert was unable to attend the meeting.

The minutes of the May meeting and the treasurer's report were both approved.

### **PUBLIC COMMENT**

Mr. Perry Jamieson of East Main Street thanked the town for their attention and assistance with getting approval for the large tree at the alley near his home to be removed.

### **COMMITTEE REPORTS**

**Parks and Railroad Station**— It appears that the road is going to need to be raised at the water tower to assist with the water drainage. Zoning Administrator Tamera Wolfe will look into getting estimates for this.

**Building**— Bryan Gabriel is looking into getting new doors for the town garage. He will also arrange for the inmates to paint the garage when the weather clears up for a few days.

Mayor Spielman will take care of having these straightened. **Planning and Zoning**— The County has added a new require-

ment for the Comprehensive Plan. Once they get the proper data to Kimberly, she will work on completing this element. **Battlefield Advisory** 

**Committee**— this meeting will be held on June 6th. Mr. Jamieson will get the notes to Kimberly to place in the crier. **Public Safety**— Nothing to report.

Mayor's Report- Individual's from the county met with town officials and the engineer from Frederick Seibert and Associates on May 10th to review the Watershed Implementation Plan. This Plan would require the town to modify how certain practices are completed in the town to prevent contaminants from entering the water way, and in turn the Chesapeake Bay. These measures include refraining from using pesticides on town property, etc. The town will review these measures and establish a plan on how to go about implementing them.

# **OLD BUSINESS**

**Bike Racks**— It was approved to place bike racks throughout the town and also to place new benches in the town square area. It was also approved to place new benches and trash receptacles at the town park. Jennifer is working with the Canal Town Project to obtain a grant for these items.

# **NEW BUSINESS**

**Ball Field Lights**— GE Ingram, President of the Sharpsburg Little League, was present to ask permission for the ball field lights to stay on until midnight for the girls softball district tournament June 18-20th and for a state tournament July 7th and the week of July 14th. The town granted this request. It was suggested that the little league draft a letter to the residents that live around the ball field to inform them of this arrangement.

**Parade**— this year we had issues with cars being allowed to cut through the parade, causing upset parade attendees. Mayor Spielman will address this issue with the police department.

The meeting was adjourned at 8:50pm. The next meeting will be held Monday, July 2nd.

# **Property Upkeep**

With spring here and summer fast approaching, weeds and grass are on the move—up that is.

The Town of Sharpsburg ordinance, Chapter 16, Article Two, Section 2-2 states that "When the mayor and Council of Sharpsburg, or its designated representative ascertains that the owner, occupant or person in control of any lot or lands within the Town has allowed or maintained on such lot or lands any growth of weeds or other rank vegetation to a height over 12 inches or that noxious weeds are growing on lands within the town, it shall cause written notice to be served upon the owner, lessee, agent or tenant having charge of any lot or lands within the Town, that weeds or other rank vegetation must be cut to a height not exceeding three (3) inches, or that noxious weeds must be destroyed by any of the methods, and that cutting of such weeds or other rank vegetation or the destruction of noxious weeds must be commenced within five (5) days after the service of such notice. If any such order of the representative of or from the Town issued under the authority of the provisions of this section is not complied with within ten (10) days after the service thereof, then the Town may cause said growth of weeds or other rank vegetation to be cut to a height not to exceed three (3) inches or shall cause said noxious weeds to be destroyed and the expense incurred incident to said order shall be paid by the owner of said lot or land, and until so paid shall be a lien upon the realty and recoverable as other liens on realty in the Town.

received several calls in regards to high grass and weeds, causing breeding grounds for snakes, rats and other unwanted creatures. These animals are on the move and into your neighbor's property. With summer vacation starting, children are outside playing and need to be protected from these animals as well. Please take care of your property, or make the proper

arrangements to do so.

### Dumping of trash and debris

It has been observed that there is an increasing amount of grass clipping, trash and other material that is being put into the town waterways (i.e. pond, streams, springs, etc.) The town waterways are not personal dumping grounds. This debris causes pollution, back up of the water way, harm to the fish and vegetation that live in these areas and is a hazard for the property owners that own property along these areas.

# **Battlefield Advisory Committee**

Susan Trail and Ed Wenschhof attended a NPS workshop on the Shepherdstown Battlefield Special Resource Study. A National Historical Landmark study determined that the battlefield is not nationally significant in its own right, so it would need to be attached through a boundary adjustment to either Antietam National Battlefield or Harpers Ferry National Historic Park. An Environmental Assessment will be prepared to look at the possibility of a boundary adjustment.

### July 4th Activities




